RE: NOTICE OF PUBLIC SALE OF COLLATERAL

To Whom it May Concern:

Please take notice that Howard McLure, an individual (the "Secured Party") is the holder of that certain Promissory Note, dated July 1, 2022 (the "Promissory Note") issued pursuant to that certain Security Agreement dated as of July 1, 2022 entered into by Second Street Restaurant, LLC, a Florida limited liability company ("Borrower") in favor of the Secured Party (the "Security Agreement").

The Secured Party's security interest in the Collateral described in the Security Agreement was perfected upon the filing of a State of Florida Uniform Commercial Code Financing Statement with the Florida Secured Transaction Registry on August 4, 2022 (the "Financing Statement"). Based on records with the Florida Secured Transaction Registry, Corporation Service Company, as Representative, filed a State of Florida Uniform Commercial Code Financing Statement dated September 20, 2023, thereby perfecting a security interest in Borrower's property that is inferior to Secured Party's security interest in that property under the Security Agreement and Financing Statement.

The Borrower is in default of its obligations under the Promissory Note and the Security Agreement.

The Secured Party reserves the right to add to, withdraw or otherwise modify or amend in any respect whatsoever all or any portion of the Collateral to Be Sold listed in Exhibit A as being subject to the Sale, for any reason whatsoever. The Secured Party reserves the right to credit bid all, or any portion of, the secured indebtedness at the time of the Proposed Sale.

Borrower is entitled to an accounting of the unpaid indebtedness secured by the property that the Secured Party intends to sell. Borrower may request an accounting by calling the undersigned.

If the proceeds of the Proposed Sale are less than the amount owed to Secured Party by the Borrower, the Secured Party may seek to recover such amount from Borrower and/or any secondary obligors in accordance with the Security Agreement and applicable law.

By selling and purchasing the Collateral to Be Sold pursuant to the Proposed Sale referenced herein, neither the Secured Party nor any purchaser of the Collateral to Be Sold shall assume any liability or obligation whatsoever regarding any debts, expenses or liabilities of the Borrower or any other person or entity, and all such debts, expenses and liabilities shall not be assumed or deemed to be assumed by the Secured Party or any purchaser. Neither the Secured Party nor any purchaser shall be, or shall be deemed to be, a "successor" of or to any Borrower or any other person or entity for any purpose.

The Secured Party reserves all of its rights and remedies, of any and every type or nature whatsoever, against Borrower and all other persons and entities for any and all deficiencies under any obligations remaining due to the Secured Party after the Proposed Sale. The Proposed Sale referenced herein is not intended to be, nor shall it be deemed to be, a "strict foreclosure" or "acceptance of collateral in full or partial satisfaction of obligation" as set forth in Chapter 679.620 of the UCC.
